



# Application Materials for Official Position, Director

As is obvious, the professional position involved with me here is more than usual. I am accordingly presenting some more than usual facts and merits involving me. I have to present them so that you can, would, and know to deal with me concerning the professional position involved, Director. You would not, and would not have justification to, deal with me so honorably if there were not such significant facts and merits involving me. I was honest and open with what I present here, so a matching up to the substantial and honorable levels is appropriate and necessary involving the professional position and its presentation to me.

The professional position package must include a declaration of job honor. The honor aspect is because even before the start, the position is understood instantly as being more than usual and one that is primarily based on high degrees of honorability. In other words, there can be no firing of me from the professional position given to me as an honor. I cannot be fired, terminated from employment, told to leave, pressured to resign, or anything of this kind. Anything and everything has to be mutually worked out with me.

There can be no negative critiquing or unagreed-with limitations of resources deemed appropriate. No one can have broad-sweeping authority over everyone else and without adequate mutuality, and myself, and each official, representative, and agent, has to have freedom, autonomy, and rights, to personal space while working. At the same time, each person has responsibility to maintain appropriateness and ethics. I myself have worked through many years before I was rewarded and honored as I should have been, and I am well-proven and very advanced, so I earned the honor and respect due me. A part of my professional position benefits has to include honor due me and shown to me in ways such as job freedom, autonomy, security, status, and tranquility.

There can be no quotas I have to meet. No standardized expectations can be set, and no time constraints are acceptable. No mechanical, automated, or technology systems are allowed to be uncontrollable and not subject to overriding, stopping, slowing, or altering. Any quantitative illustration will be subject to a qualitative evaluation, and the same goes for the other way around. Quotas, statistics, polls, surveys, and rates can only be used as guidelines but may not be used strictly or as static, rigid, or effectually measurable in any negative way.

For adding in additional information to follow-up on previous communication, I am including material relevant to the doctoral program. I explained how I earned my doctorate by in 2012 after 5 years but was wrongfully and unjustifiably not issued my doctorate through the following 5 years, amounting to 10 years in a 3-year program. I am now further backing my emphasis by including a link - https://youtu.be/6KPd7P9HUPc or

https://www.youtube.com/watch?v=6KPd7P9HUPc&feature=youtu.be – to a recording of chapter 5 of my dissertation (which is made accessible from now to through the month of December 2017). I present the material as a top-quality work and further expressing what I have been saying about, and I do not present the dissertation material for any other purpose and especially for any lessening, degrading, or contrasting. I do specifically request that only reviewing my chapter 5 with proper intent be done because not only do I want my doctorate that I earned by in 2012, but I also want my U.S. Government director job and my past 10 years of honorable work to be treated right.

Being that there has been so much trouble with education, the area needs evaluations and balances. Education is something that is important and good, but it is also something that can be abused and misused. I went through many years with good credentials and without them being effectually honored in business. I became very advanced in education itself, in addition to business, and went through more than 5 years without receiving respect or honor due in education and also without receiving my doctorate I earned through the previous 5 years. Everyone else was definitely not treated like that, although many people were not treated right, and there was no adequately functional policy for fairness in those years concerning education.

In addition, the student loans issue was never truly taken care of because being regarded enough or along with the education is necessary to honor the person to points of the person being able to afford to pay the student loans back. achieving further accomplishments, developing, and credentialing to advance in one's career and life. In addition, all my student loans from past to present must be totally eliminated in terms such as bestowing a student loans relinquishment honor to me for my past more than a quarter-century (25 years) of work relevant to and important concerning the United States.

I considered that my formal application and resume should be included. I attached them. My United States application materials present through the past 10 years can also be accessed on usajobs.gov → https://www.usajobs.gov/Applicant/ProfileDashboard/Resumes/. The material goes through the past 10 years. Material remaining worthy and successful through 10 years before being recognized should be correctly understood and treated right. I present the material here, and I reiterate and back every expression made in the material.

You will see some substantial facts expressed in the material. These substantial facts are mentioned so that they can be understood as already having been involved and worthy for honorable progress in all ways and including with the professional position. Expressed about are merits and worthiness that are among the most there can be and as much as expressions can emphasize. 

1. ECQ 1: Leading Change - Involves the ability to bring about strategic change, within and outside the organization, to meet organizational goals. This country, U.S.A., was set up to have three branches of government: judicial (judiciary), legislative (Congress and Senate), and executive (Presidency). This enables checks and balances so that the government always stays functional. States are governance entities within the bounds of this country, U.S.A. Within the states are numerous local governments such as cities and counties. A political appointee is someone a public official appoints to hold a position, and this is as opposed to a position that is an elected position. Interest groups are people organized together to advance or protect some particular interest.

Various strategies remain possible to work accordingly concerning all parties involved and with their interests kept considered and balanced. An article reviewed was the author, Bartel (1987) interviewing a political science professor, Adams, and this consisted of questions and answers addressing political concerns. One question Bartel asked Adams was what advice to give to U.S. Congressmen and Senators. The answer Adams said was overwhelming congressional representatives and senators with many little decisions has happened too much, but a better situation would consist of unifying people's freedom with the interests of public interest groups and synchronizing free enterprise with democracy.

Communication is always something important, and upholding communication accordingly is another aspect relevant. Letting the emphasis be what the expression meant increases understanding and enables a correct outcome. Maintaining the importance of communication being valid keeps the communication real and having proper value. Persuading good faith effort made continually is another quality additive to functionality between people, groups, and organizations. Always important too is upholding the interests already worked in accord with, which includes keeping successful all relevant business involving these interests.

Through the past years, work occurred concerning all the various levels of governance. Working on local levels occurred, and city, state, and national levels of work occurred too. Performance of this work completed in various ways and at various times through the past years. The main necessity was always for what was involved with *God's Miracle Cross* to receive its due furtherance, honor, and reward (Mallon, 2006). After all, this cross was an authentic miracle in this country, U.S.A.

When being in a leadership role, a good job has to accomplish, as with any job. However, along with leadership comes many advantages. People listen more to what the person emphasizes and regard more concerning the person. Additional pay and incentives are likely, too. Beyond this, the job is more fulfilling.

High-level inspiration is an experience when accomplishing meritorious achievements while in a leadership role. When being so inspired a person in a leadership role can and ideally will pass on enthusiasm to subordinates. This inspiration helps subordinates to do a good job and be successful on their levels.

A leader doing well may also be a role model for other people and may set many standards concerning other people. A leader who does well will excel in the leadership role and will further develop in the person's career because the position has enough capacity to enable this development. A position that is less than a leadership position may not be able to do or accomplish any of these things that a leadership role can.

Being a leader is not always easy. A leader has to be a responsible person, and has to be successful in the interests of all stakeholders. In an article reviewed, the author (Maak, 2007), says that business scandals in past years caused people to realize that responsible leadership is necessary. The business will be successful only with responsible leadership.

Maak (2007) explains the inappropriateness of taking risks for merely a few thrill-seekers, and instead, the many stakeholders have to receive benefits. Leaders have to be responsible for what they do and have to consider all stakeholders before doing

something that will produce some kind of results. Results have to be pleasing and of benefit to the interests of all stakeholders.

The stakeholders include sponsors and people working along. People who have some kind of monetary amount at stake are stakeholders even though these parties are not directly working with the leader or business. In addition, the people who are working directly with the leader and business are stakeholders. The leader has to do well involving the people who are working directly along because these people are also stakeholders.

These people working directly along, who are also stakeholders, have to receive motivation to do well. They have to have guidance to do well. These fellow workers have to have their appropriate amount of empowerment to maintain themselves and justify the work they do without needing to be overly concerned about doing anything. These people have to have their level of freedom to perform their best and to strive to improve and accomplish notable achievements. The leader sets the structure for personnel to be successful.

A point of interest concerning *God's Miracle Cross* is that this phenomenon remained preserved for more than 25 years so that people would have an ability to deal with this miracle cross. If the preservation did not happen, no one would be able to deal with *God's Miracle Cross* at all. Answer: Working is doing something, and each work done is an accomplishment achieved. The person who does the work earns a reward, and the party for whom the work completes pays the reward for the good work done on that party's behalf. The person who does the work takes pride in the work because the work's effort and quality are valued. This situation makes the person more responsible for the work because the

person cares about the work done. The party paying for the work has interests in the work too and is a customer or client. When the customer pays for a good work and the worker receives the money for the work, good business has resulted. Business of mutual benefit is the ideal.

After doing a work for a first time, the basics of doing the work remain known, so the work can complete a little better the next time. After many more times of accomplishing the work, skill perfects, so potential exists for adding to the work progressively. Making a good faith effort to do better work or provide better service is a situation of continuous improvement.

Sometimes all work involved with a project cannot just be easily done in a short time, and before significant advancements have been made, full support or funding may not be available. A building up of the support and funding is necessary although may not just happen quickly or easily in the immediate times. A continued devotion to the project's cause is essential, and keeping the work progressing must result, but true benefits will not be realized until after support, rewards, and honors are present. Keeping everything going may require additional work. Contingency plans may need applying, and a little extra maneuvering may necessitate. With the work or project truly being worthy, all holds up and just needs to progress further to points of being able to stand alone.

God's Miracle Cross is the most significant aspect involving me. I have not yet received rewards, nor have I yet participated in any mutual work done officially or on primary levels concerning this miracle cross, and the present time is after more than 25 years. Many achievements accomplished involving God's Miracle Cross. The design of this cross has acquired a patent and copyright. Originating many text documents has resulted. Books authored and copyrighted additionally resulted, and the first book went into the public domain in 2006 (see Appendix). A company, God's Miracle Cross Company, Inc., was incorporated in 1995 based on this authentic miracle.

Much communication relevant to *God's Miracle Cross* remains around. The creating and maintaining of specialized websites occurred too. Originating advanced materials relevant to *God's Miracle Cross* continued through an MBA program, and this advanced creation remained done through a doctoral business program and proved to go beyond the abilities of the university itself. Plenty has already accomplished, and much more still has to result, but also, what is very important is that the issues involved in these directions receive due diligent work in the rewarding and honoring ways appropriate.

This situation is not something arbitrary because work on *God's Miracle Cross* has been being done through more than 25 years, and the company, *God's Miracle Cross* Company, was incorporated in 1995 and is currently more than 10 years old. Therefore, the true situation is well established and is primarily just a situation requiring advancement aligned with rewards and honors due.

5. ECQ 5: Building Coalitions - Involves the ability to build coalitions internally and with other Federal agencies, State and local governments, nonprofit and private sector organizations, foreign governments, or international organizations to achieve common goals. Competencies: partnering, political savvy, influencing/negotiation.

Answer: Communication is always a base necessity, and unifying enables progress on group and organization levels. Not much will result without a sufficiency of

communication, and for the presentation of or response to information, communication necessitates. For any kind of agreement, communication is required, and ethical business practice includes an adequacy of communication. The communication may be in any form and to any degree, and appropriateness is all that is necessary. Adequate follow-up may require, depending on what the communication involves. To work issues out requires dialogue between parties involved, and this dialogue must continue until reaching an agreement. Communication in business has value and could involve much additional that has value.

Plenty of communication transmitted involving *God's Miracle Cross*. This specialized communication occurred because this reality was something that had to have work done and for the first time without ever having been accomplished before. Because this reality did not ever previously have work done, greater difficulty was involved with dealing with the miracle cross. Hello John DeStefano,

I am communicating again here because of the rightness of the timing and various aspects involved. We have Internet capability in these times, and enough physical has to also be included. I have expressed interest and worthiness of an advanced professional directorship level professional position with the United States government. I am sure that you here know when a person is officially dealt with or not by the United States, and you know how to reach me if intending to for real. All continues as I expressed here and in my previous communication, and I am presently watching and evaluating with approximate monthly time intervals to the end of this year of 2017.

### Doctor of Business Administration since 2012

I achieved A final grades in all of my last courses of the doctoral program in 2011 and 2012. These courses included standard doctoral courses and dissertation courses. By when I finished my last course of the doctoral program, I had an A level grade point average (GPA) and an excellent, more—than—passable dissertation. I immediately submitted my dissertation into the Quality Review Final (QRF), which is similar to the old—style dean's office, for final review. My emphasis was that the university should apologize to me and send my dissertation back into the QRF to be done right. I had a meeting with some of the faculty members, but following, they did not proceed in cooperative ways. I had to just do more myself, as I certainly did through the next months and years.

Without reviewing everything all over again here, I truly earned and should have received my doctorate in 2012. I want that dealt with by officially recognizing me as earning my doctorate in 2012 and then doing post-doctoral work since then in 2012 to whenever a full settlement here is reached. I want to be understood as being a doctor in my field since 2012. My dissertation has to be published in a successful manner fitting for an honorably completed doctoral program, worthy of any doctoral or Ph.D. level. Concerning here at the White House with the Trump administration in Washington, D.C., I request that these mentioned aspects be understood and included as a part of my professional position package for my directorship division of the United States Government.

### Status to Honor

When working with me, transitioning has to be done, but also, the transitioning has to include with me being on my directorship levels. I have to be securely working in my leadership capacity because I cannot be misunderstood as being on any seemingly inferior or subordinate level, and I cannot have to go through years or any amount of time waiting for others to deal with me as being on my right status level. In case there was any wondering here why I previously sent the relational letter, I will further explain a little here. Mainly, I wanted the current administration to know a little about what was going on. I wanted to further express about a little of what I have been confronting and why I do or say some things as I do. In addition, I have written about this situation since many years ago. The time consideration shows in the relational letter, which expresses the past more than five years and with the clock still ticking.

I originally wanted my wife and was everything good for her. Something was constantly wrong on her end of things, though, because out of everything and no matter what, I kept not getting dealt with right. Communication was excessively not made to me. When she had

practically all the resources in the world available, nothing was worked out with me. I was left not dealt with and with everything still requiring.

Presently, I still want my wife, but also, again, take a look at the time that the relational document expresses. I am not sure if the woman involved can even deal with me at all or be or give me my wife. The situation was not like this years ago, and we only had to get together and stay together. I only had to be properly dealt with, but now, I am not so sure, even if I am dealt with. At the same time, though, I still have to be dealt with and have rights to my wife.

I included this relational area here because of the situation and professional position involved being more than usual. I would not usually include this area when expressing about a professional position. I do not usually say about these things while working. There is relevancy here, though, because of the 30 years of United States involvement and high level Federal Government position involved.

The described woman will have to be vetted as having right intent. She will have to be making her efforts to deal with me and to work out the situation with me as best as she can. She will have her work to do and plenty of it, and she has to be doing her work. She has to know and be responsible concerning what is going on involving her and us, and I cannot have to excessively explain about anything involving us.

I covered this relational area as I should. The rest has been explained in past years and in many different illustrative forms. My authority, wisdom, rights, and worthiness have to

be respected in these directions. These requirements continue as time goes on and concerning everything there is and everything done.

I think that she would have to agree to and sign a formal document saying that she will faithfully cooperate and will not now or ever contrast or go against anything involving me. The time involved is so much that some extra assurance is needed. I will keep good intent, but I cannot be pushed or not regarded concerning what and how long I went through. She has to do enough of what she is supposed to do and give a little on her part, even so that I can be doing what I should be doing on my part.

There is much more to say in this area, but it is not needed here. I just wanted to cover this area because of its relevancy and importance and because I previously sent the relational letter. The situation involved is still active and ongoing. I further feel that everything here in my interests would be good for her.

## Timing of Active Communication

The time of this message is finishing October and going into November 2017. I have expressed about my background and have shown my consistency through the past six months. The background and consistency will assuredly continue, but also, I would like to see some solid progress made here with the Trump administration and the United States government. By Thanksgiving, the situation would be good if I was to receive word back saying at least that I am being worked with in mutually agreeable and progressive terms.

By Thanksgiving, I will see that I am either dealt with to some extent, or I am not. I will then set my sights on Christmas and going into the new year, and of course, I will either be working with me being dealt with or working with me not being dealt with. I can say right now that I would prefer the positive reality of seeing some progression made, and I will definitely be noticing and dealing with what I see the situation is involving me and concerning the United States.

## Talking about Authority

The area of authority has to be covered, too. I have to have my authority. My authority has to be high level and fully secure. This authority has to have its degrees of strength, independence, and virtue. The job needs the authority built into the professional position, and the levels, merits, and necessities justify the applicable authority.

I do not express here about authority egoistically. I was supposed to have authority years ago. I was supposed to be a lawyer and a very important person (VIP) of the United States, and I have worked in these ways with everything requiring for more than 25 years. I additionally was supposed to be a doctor in my field of business administration for more than 5 years now (since 2012). I had to go through a quarter-century before being dealt with, rewarded, and honored.

The professional levels involved did reach these points through past years. There was always much potential and importance, but also, with all involved excessively not dealt with and left requiring, many difficult times were caused. I went through all that turmoil before

being honored concerning the meritorious aspects. Regarding all that time and turmoil while preserving much important to this country, the United States of America, there is a serious side, and there has to be authority where it belongs. For these, and other relevant reasons, I express that there has to be authority I have included in my United States government professional position, director.

## Further Updating Report on U.S. Education Issues

I previously provided information about a type of legal action taken against online universities, such as the one causing me to not formally complete the doctoral program in the very ending times for 5 years and after 5 previous years (10 years in total). The organizations involved with working on the appropriate legal action, apparently had everything backfire against them. Although people like me, who were their clients, waited patiently for 5 months or longer for right results and had years of legitimacy, quick action was taken against these organizations. I would truly like this legal action looked at and considered for further work in appropriate, equivalently effectual ways. One question that jumps out is - What happened to the work the U.S. Department of Education was doing? There were many people, myself included, who had legitimate complaints against these strayed online universities, such as the one I have expressed about, the University of Phoenix.

As another part of my directorship post with the United States government, I want included authority to work on these education issues. My authority has to be equal or superior to the authority of anyone else involved or who will have or make any say of true

consequence. I cannot be the only one doing the work, but I have to have my authority and see what I should be seeing, and the people, myself and others, working in these educational directions have to be taken seriously, respected, and advanced with the true cause of action.

### Further Considerations Relevant to Stakeholders of the United States

Consider some of the issues coming out now in 2017. Seemingly legitimate people, and entities vicariously, were found to be acting totally illegitimately and unlawfully. According to the latest series of events in these education directions, this area appears to be another one of those harshly criticizing and accusing, quick-actioned areas that have more involved than only righteousness, worthiness, honorability, or lawfulness. Retaliatory character attacks are not acceptable, and discrediting of work or credentials are immediately questionable and subject to further scrutiny. Full reports worthy and legitimate have to be regarded as top priority. All here is meant to be understood correctly and is not meant in any kind of reversed way.

Further consider that the situation would have been better and righter if I was dealt with through the past years of 2009 to now in 2017 and instead of the improprieties through those years. Relook at those director level United States Government professional positions I submitted applications for up to in 2011. Consider the very worthy, highly successful, and extensively honorable dissertation I made and doctoral candidate status level I achieved by in 2011. Shortly following while working professionally, I became licensed in each state of the United States and the District of Columbia–Washington, D.C., and I maintained that licensing

and professional success from 2011 to now in 2017 and before being rewarded or honored concerning that merit or success.

I continued diligently working professionally, and I earned my doctoral status and continued as a doctor in my field and while working in post-doctoral academic levels through those years of 2011 to now in 2017 without or before proper crediting, acknowledgement, or support from parties involved, such as the mentioned university. I actually finished the true doctoral program in 2012 and had an A level grade point average (GPA). I am not only extensively qualified for the directorship with the United States Government, but this directorship is truly very much needed and requiring concerning the best interests of all involved with the United States. That is also why my dissertation and the doctoral program is still requiring to be worthily finished on fully accredited American university national levels. A university not qualified or capable of doing the involved doctoral work cannot do it. Left requiring is the necessity for a qualified American university to complete the university part of a doctoral program finished in 2012 and continued with post-doctoral work from 2012 to 2017.

### **ORDER**

I have an excellent dissertation that is for me to receive my doctorate. My specialty area is business, so the dissertation is business oriented, although also included are other areas, such as education, law, politics, and religion. My dissertation is very advanced, which means it goes beyond usual and includes various luxury components in addition to all the necessities for meeting top quality doctoral standards. ## Report on Summer of 2017

The time is due for a follow-up emphasis from me. The summer season of 2017 is winding down. My previous communication was in the early times of the summer. Much was done through the summer, and many successes were achieved. A report from me in the ending times of the season adds as a reminder that much was there through the summer season and was a part of the active situation, the projects done, the background platform, and the continuing potential.

## **Active Situation**

The situation continues as it has been but also with consistent earnings, merits, and successes accomplished and requiring honor due. The positive attributes have been being excessively dudded out, negated, or contrasted. Rather than the devaluation, there should be facilitation, enhancement, and inspiration. A full amount of success was steadily achieved through the summer of 2017, but another important aspect is to see enough come of the success achieved. The positive movement and advancements have to be there, too, so that the situation improves and the work and successes are worthwhile.

## **Doctoral Program and University**

I also worked more on my dissertation through the summer. I truly should have been let to finish the doctoral program in 2012. I was caused to work through the past 5 years (in addition to the first 5 years, 10 years in total) just on finishing the doctoral program. I recently took 3 more courses in the doctoral program and achieved A grades as final grades in each of the 3 courses. After all that, the university continued with backend burdens that did nothing but cause delays. At the time of going into the end of the summer, I received an assistant dean level declaration that my entire work was inferior in every way and was impossible to meet doctoral standards, and everything would have to be done over.

When I finished the doctoral program in 2012, including with standard courses and dissertation courses, I had an A level grade point average (GPA). My dissertation was good and more than passable for ending the doctoral program at that time. My dissertation remained good and more than passable through the next 5 years, but the university would not let my dissertation pass and me to get done the doctoral program. Just recently, after the 3 additional courses I took, and did very well in by achieving A grades as final grades, the university practices caused the whole summer to go by without getting the university's work done to finish the doctoral program. Then the faculty member on the assistant dean level of this university made the belittling expressions concerning everything involved on my part.

I previously took appropriate actions concerning the unethical university practice. I continued this appropriate action. This action was not just me. I had already a long time ago did all I could do. I continued to do what I could and to do the good I do, but more than only myself alone had to continue to build and, too

much so, remained fully justified to continue. There was a form of legal action taken and advanced concerning this university and other such universities. These types of unethical practices had been going on too much and for too long, and many people have been being negatively affected, including myself.

I would like to see these universities corrected and be put back on track to be the way they are truly supposed to be. They need to be set back on course and be providing accredited education that meets societal standards and that is also with proper intent of providing people with a favorably memorable experience and facilitating, developing, and educating people of the society to advance in their careers and lives. These universities should be endeavoring to be comparable to any of this country's universities. They should not be lowering their standards or lessening people they affect but rather should be constructively elevating people to higher standards. That does not mean just holding people to higher standards with no benefit to these people, but this means to actually improve people to reach higher standards and achieve a mutually desirable end-result.

As good as can be thought or emphasized in the directions of these universities, they have not been doing as they should and have to do better. This emphasis is not against all people of these universities but is that no person or people should cause bad situations or damages in or with the universities. I presently continue watching for results of actions taken.

After seeing an adequacy of progress, further work in relevant areas will be done. The next relevant endeavor is to have ways of successfully clearing all or most academic types of debt. There will be secured multiple ways for people, and myself included, to reduce any academic debt down to zero.

## **Professional Position**

With how I have been working, the levels have been lower than can enable contentment. The best that can be done in the situation is what has always been done. I always did very well and remained successful. There have not been many benefits. The slow rate of progress has been the worst of it because out of everything done and all the time that passed by, the situation is basically the same, whereas with some upward movement, there may have been more possible and that worked out. Promotions, raises, and opportunities have been lacking, and the best that could be done was to keep the same work going and to consistently remain successful without benefits of upward progress.

I have plenty of potential kept in the background and unused as the time passes by. The job involved only calls for what the job involves, and the rest is not appropriate to use. I will not do anything additional unless I have the job where more is applicable. This practice is necessary because the potential areas are not wanted or honored in a job not suited for them, they are not paid for, and they are not supported. I will not budge from the job I have had or work I have been doing unless a bona fide offer of a truly better, more career progressive, and higher-level

job is made to me. I am a professional person, have been very successful on the levels I have been working on, and have worked straight through the past more than 6 years like this. I am professionally licensed in each state of this country, the United States. I have had this licensing through the past years. A professional package would have to be presented to me in order for me to think anything of it or deal with it, especially realistically.

If I was to receive a legitimate offer of an appropriate level professional opportunity, I would instantly work with it and begin building up with it. If truly appropriate, I would give at least two weeks advance notice to where I have been working. There would not be playing around in these directions, and real actions would be taken. There would be real money involved and including money I am being paid.

I would like a successful amount of money set as a pay in the beginning, such as \$80,000 to \$125,000 yearly to start and with a bonus of \$10,000 to \$25,000. The only aspect of this pay is that this amount is what the pay should be. I will still have to have set openness for pay raises and bonuses, and I would like to have other finances worked out, too, since I have financial aspects involved with the United States since back in the 1980s.

## Unique Historic Features and Potential

I first wrote to the White House in 1983. I said about a discovery I made here in the United States, a cross that eventually became referred to as *God's Miracle Cross*. I worked through 7 years with this discovery and did send communication to the White House at various times through those years. I always did well, but there was great difficulty in getting the discovery dealt with in rewarding and honoring ways. I eventually had a design of the discovery patented and later copyrighted. I also authored books through those years, and because I was so advanced intellectually, I went through college and went into law school.

As I was in law school, the first Iraq war happened, too. I was at a time when everything required its due attention but was not getting it. Law school could not and did not continue like that, but because I was working on the level of law school, I did various lawyer levels of law work. I eventually made law cases in the United States courts. These law cases turned out as difficult to impossible to have worked out concerning the actual issues involved.

The law cases were made in the U.S. District Court for the Eastern District of Pennsylvania, then the U.S. Appeals Court for the Third Circuit, and all the way up to the Supreme Court of the United States, but all without the issues involved being worked out. I was then left with nothing worked out and everything still requiring. I made more efforts through all the years of the 1990s to get the matters dealt with, and I worked and worked through all those years and also became and worked as a business owner. The years of the 2000s were then gone into, and I communicated

abundantly, kept open communication lines, and made full efforts for the issues involved to be worked out, but the stakeholders were very stubborn in those times.

I kept working diligently in every way appropriate and kept communicating and maintaining open communication lines. This situation continued into the year 2000, through the year of 2001, and remained continuing like this to in 2003 when the second Iraq war started. By this time, I started working on an MBA degree, and the whole situation continued in this way until in 2006 when I finished my work on the MBA degree. I received my MBA degree in October 2006, and at the same time, I published my first book, *Dream Book: From the Book of Dreams*. I further communicated extensively and including to the White House.

In my communication to the White House, I said about issues involved, and I said about the MBA degree and included a copy of my first published book, *Dream Book: From the Book of Dreams*. I then followed with timely job applications to add to potential of the issues involved being worked out. The trouble was that the situation continued like this without reciprocity on the stakeholders' part. Because I saw this disengagement situation happening, I went into a doctoral program to advance my MBA level to a DBA doctoral level. The professional positions applications continued through these years to passed 2010, but I was left without my public office worked out.

With this situation being as it was and with me already being advanced in business, I progressed in the field of insurance as a licensed agent. As previously mentioned, I eventually reached a point of being licensed in each state of the United States and also Washington, D.C. I worked in this manner through the next approximately 5 years. My financial credit score reached over 700. I kept maintaining a successful situation and loaded with potential in various ways and on multiple levels.

I also continued on the DBA doctoral level to a doctoral candidacy, which remained continuing through the past approximately 5 years and as previously described. I remained very successful and with an excellent dissertation but was not let to finish the doctoral program and to receive my doctorate. Now I have an excellent dissertation and have nowhere to go with it.

### Back Up to the Present Times

I remained successful through the entire summer of 2017. As I am sure is known here, I communicated to the White House before the summer. I received good word back. I followed-up a little with an emphasis of some of my background to show some of my potential and a little of what I have been confronting. I wanted the current administration to know a little of what has been going on.

I was not sure whether I was merely being forgotten about or whether any building was being done at working out anything professionally with me. I thought I would make this report as something appropriate for me to do and to add to an understanding of events through the summer and continuing. I would then look for

a response or see I do not receive a response, and the same is so with something being worked out professionally with me. Either way, I will stay on track and remain successful, although I would prefer me being dealt with and something being worked out professionally with me. A main concern I have is that if I keep not being dealt with in times I truly should be dealt with and by people who should deal with me, then exactly when am I going to be dealt with and by what people, if any people ever.

### **National Issues**

With these areas involving me being included, situations are affected, are different, and reach different results than without the inclusions. If considering national level issues, the differences could be very substantial and serious. The better and most appropriate situation is with the inclusions. When taking on any national level issue, there would not be wisdom in leaving out many important facts and resources. The national issues would all be better off with the inclusions of these areas I have been mentioning about.

I would like to work on national issues. I could say here about various national issues that have been active, but everyone knows of the national issues, and I do not want to just waste time or make statements in areas outside of my job bounds. I am just expressing here that if I had the job, I would do it and would be the best at it, including in terms of providing consultation, preservation, and actions concerning any and all national issues. This type of work is really what I should be doing, and much around involving the national issues needs my additions. A professional position that includes and is on the level of working with the national issues is appropriate to be worked out with me and probably more so than with anyone else in this entire country or on Earth.

## Conclusion

I am presently continuing as I have been and as expressed in this report. I could be and should be presented with a professional position package of an offer made to me in regard of my credentials and rights. I touched on these areas in this report. I kept the report inclusive and more than usual but also brief and concise. This report was also for the purposes of backing the appropriateness of my questioning of whether a professional position would be offered to me and better enabling the opportunity presentation to be done.


There are more than 22,000 American children in New Jersey.

### March 2018

Hello John DeStefano (and the Trump administration),

I presented material through the second half of last year of 2017. I said about working out my professional position of director. 



The time has come for the disputes to be settled, the honor and authority to be where is right, and for there to be an adequacy of cooperation and mutuality among the parties involved. Because of this entire situation going on in the present era through the past more than a year, truly relevant progressive situations have to continue through a substantial amount of time.
